Members present: Chaplain Donna Hale, Shelby Holley, Denny Minnich, Don Mowery, Jeff Noble, Dave Rohrer, and Bill Webb.

- I. The meeting was called to order at 7:01pm and an opening prayer was given by Chaplain Donna
- II. Motion to approve Minutes from the July meeting by Jeff Noble, seconded by Bill Webb. All in favor.
- III. Dave Rohrer reported to the committee, as informational items, that Thank-You letters were received for our donations of pasta sauce, \$375.00, and \$250.00 towards Fill the Bus to Project SHARE; Maranatha (\$1000.00), and Domestic Violence (\$375.00).
- IV. OLD BUSINESS
 - A. Follow-up – CELTIC MARTINS JULY 13: @130 attended - \$316.00 collected for Hope Station
 - B. Follow-up – ICE CREAM SOCIAL – was held indoors because of rain and @80 attended. Donations in the amount of \$230.00 collected for Meals on Wheels
 - C. Follow-up – BACK TO SCHOOL BASH AUGUST 17 – a grant of \$1000.00 was received from the Conference; need a couple of volunteers for this Friday’s event between 4pm-8pm.
 - D. My Brother’s Table – held Saturday August 11; 71 meals of hamburgers/hot dogs/baked beans/apple sauce/cookies served; 7 volunteers helped to serve and clean-up. Consider having more hamburgers available if this meal is offered again. Also consider food for vegetarians.
 - E. Adopt-A-Horse Ministry – handout distributed about this UCC Ministry. Dave Rohrer reported that Byron Buffalo, one of the leaders of this ministry in North Dakota, passed away suddenly about a month ago. Chaplain Donna is making contacts to check on the status of this ministry. We will revisit this topic in September
 - F. Church Shirts – no follow-up to this as Pastor Chris was on vacation. Revisit in September.
- V. NEW BUSINESS
 - A. SEPTEMBER SPECIAL OFFERING - The council discussed local organizations that we have not recently given a donation. Chaplain Donna motioned the September Special Offering go to Big Brothers/Big Sisters. Motion seconded by Shelby Holley. Motion passed.
 - B. CHURCH & COMMUNITY COUNCIL BUDGET 2019 – Council members discussed the upcoming budget including specific line-items that are no longer used, some that could be reduced, and others that needed an increase. Don Mowery motioned we keep the 2019 CCC Budget at \$46,600.00, (same as 2018) making adjustments within our budget as needed. Jeff Noble seconded the motion. Motion passed. Dave will submit a copy of the 2019 CCC Budget to Iva.
